

nterstitial cystitis (bladder inflammation or irritation, also known as IC) is a painful condition that affects more than 1 million people

in the United States, mostly women. Elmiron (pentosan polysulfate sodium) is the only drug approved in the United States for the treatment of IC. Elmiron is a weak blood thinner which also works as a bladder protectant, used to treat *bladder pain and discomfort* caused by cystitis (bladder inflammation or irritation). Recent findings show that one-quarter of patients who have taken large amounts of **Elmiron** had clear signs of eye damage.

Elmiron lawsuits claim the drug causes an eye disorder called maculopathy

and other disorders of the retina that may lead to *blindness*. People who took Elmiron and suffered *maculopathy* or other serious vision problems may be eligible to file an **Elmiron** lawsuit.

**Recent findings show** that one-quarter of patients who have taken large amounts of Elmiron had clear signs of eye damage.

Claimants in **Elmiron** lawsuits accuse Janssen Pharmaceuticals of failing to properly warn the public about the risk of *ocular toxicity and* irreversible vision damage.

Research presented at the American Academy of Ophthalmology in 2019 revealed that patients taking Elmiron showed *clear signs of toxicity*.

The drug has been on the market since the late 1990s. It should be noted that all drug and medical device companies are responsible for delivering safe products and warning about potential risks: however, manufacturer negligence and flaws in the U.S. Food and Drug Administration (FDA) approval process may put millions at

ccording to the West Virginia Department of Commerce, the chemicals industry accounts for one-fifth of manufacturing

sector jobs and nearly 40% of the manufacturing sector's economic output in West Virginia. West Virginia is home to about 140 different chemical-related companies that provide over 12,800 jobs to the state. This makes West Virginia the location of one of the largest number of chemical manufacturing companies in the world.

While good for the economy, some of these chemicals cause cancer.

### **Mesothelioma & Lung Cancer**

Caused by asbestos, applications include insulation, brakes, shingles, flooring and many other products. Mesothelioma is an aggressive and extremely deadly form of cancer that can take 20 to 60 years to become symptomatic.

Often by the time mesothelioma is diagnosed, the disease is advanced. The five-year survival rate is between 5% to 10%. Most patients with mesothelioma of the lung die as a result of respiratory failure or pneumonia.

Symptoms of peritoneal (abdominal) mesothelioma can include: • Weight loss

- Swelling and pain in the abdomen
- •Blood clotting abnormalities
- •Bowel obstruction
- •Anemia
- $\bullet$  Fever

# **INGREDIENTS:**

### Myeloid Leukemia (AML)

Among the 20 most widely used chemicals in the U.S., benzene is used mainly as a starting material in making other chemicals, including plastics, lubricants, rubbers, dyes, detergents, drugs and pesticides. It's also the cause of acute myeloid leukemia (AML). The five-year survival rate for people 20 and older with AML is about 25%. For people younger than 20, the survival rate is 67%. Although AML is a serious disease, it is treatable and often curable with chemotherapy, with or without a bone marrow/stem cell transplant.

### Symptoms of AML can include:

- Skin looking pale or "washed out"
- Lethargy
- Breathlessness
- High temperature, and feeling hot or shivery (fever)
- Weight loss
- Frequent infections
- Unusual and frequent bleeding, such as bleeding gums or nosebleeds

If you or a loved one has been exposed to asbestos or benzene and has been diagnosed with mesothelioma, lung cancer or AML, you may ask, "If I file a lawsuit, can I expect to recover significant money damages?" The answer is usually "yes." People who discover they are suffering from mesothelioma or AML due to working with asbestos or benzene (or, if they are deceased, their spouse) have an excellent chance of achieving compensation.

### Zucchini Lasagna

As an IT specialist, father and great cook, Kevin Carson is a triple threat! Enjoy his favorite recipe.

- 1 pound lean ground beef (90% lean) 1/4 cup chopped onion 1/2 teaspoon dried oregano 1/2 teaspoon dried basil 1/4 teaspoon salt 1/4 teaspoon pepper
- 1 large egg, lightly beaten 1 can (15 ounces) tomato sauce 1 cup 2% milkfat cottage cheese 4 medium zucchini (about 1-3/4 pounds) 3 tablespoons all-purpose flour 1 cup shredded part-skim mozzarella cheese Additional shredded mozzarella cheese, optional

DIRECTIONS: Preheat oven to 375°. In a large skillet, cook and crumble beef with onion over mediumhigh heat until no longer pink, 5-7 minutes. Stir in seasonings and tomato sauce. Bring to boil; simmer, uncovered, 5 minutes. In a bowl, mix egg and cottage cheese. Next, trim ends of zucchini; cut lengthwise into 1/4-in.-thick slices. Layer half of the slices in a 13 x 9" baking dish coated with cooking spray; dust with half of the flour. Top with cottage cheese mixture, then half of the meat sauce. Add remaining zucchini; dust with remaining flour. Spread with remaining meat sauce; sprinkle with 1 cup mozzarella cheese. Bake, uncovered, for approximately 40 minutes. If desired, sprinkle with additional cheese. Let stand 10 minutes before serving
